MODE OF MEETING

The 19th AGM of the Company will be conducted on a fully virtual basis through live streaming and online remote voting using RPV facilities. This is in line with the Guidance Note on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia including any amendment that may be made from time to time.

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which stipulates that the Chairman shall be present at the main venue of the 19th AGM. **NO SHAREHOLDERS/PROXIES/CORPORATE REPRESENTATIVES** from the public will be allowed to physically present at the Broadcast Venue on the day of the 19th AGM.

RPV FACILITIES

Shareholders are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "**participate**") remotely at the 19th AGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("**Tricor**") via its **TIIH Online** website at https://tiih.online.

Shareholders who appoint proxies to participate via RPV in the 19th AGM must ensure that the duly executed proxy forms are deposited in a hardcopy form or by electronic means to Tricor no later than **2.30 p.m. on Sunday**, **27 June 2021**.

Corporate representatives of corporate shareholders must deposit their original certificate of appointment of corporate representative to Tricor not later than **2.30 p.m.** on **Sunday**, **27 June 2021** to participate via RPV in the 19th AGM.

Attorneys appointed by power of attorney are to deposit their power of attorney with Tricor not later than **2.30 p.m.** on **Sunday, 27 June 2021** to participate via RPV in the 19th AGM.

A shareholder who has appointed a proxy or attorney or corporate representative to participate at the 19th AGM must request his/her proxy or attorney or corporate representative to register himself/herself for RPV via TIIH Online website at <u>https://tiih.online</u>.

As the 19th AGM is a fully virtual AGM, shareholders who are unable to participate in this meeting may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the proxy form.

(b)	Submit your request	• Registration is open from 10.00 a.m. on Tuesday, 28 May 2021 until the day of AGM, Tuesday, 29 June 2021. Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to re-register their attendance for the AGM to ascertain their eligibility to participate in the AGM using the RPV.
		 Login with your user ID and password and select the corporate event: "(REGISTRATION) PMBT 19TH AGM".
		• Read and agree to the Terms & Conditions and confirm the Declaration.
		Select "Register for Remote Participation and Voting".
		Review your registration and proceed to register.
		• System will send an e-mail to notify that your registration for remote participation is received and will be verified.
		• After verification of your registration against the General Meeting Record of Depositors as at 21 June 2021 , the system will send you an e-mail after 27 June 2021 to approve or reject your registration for remote participation.

		 If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will endeavor to respond to questions submitted by remote participants during the 19th

		AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.
(e)	Online remote voting	 Voting session commences from 2.30 p.m. on Tuesday, 29 June 2021 until a time when the Chairman announces the completion of the voting session of the 19th AGM.
		 Select the corporate event: "(REMOTE VOTING) PMBT 19TH AGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box.
		• Read and agree to the Terms & Conditions and confirm the Declaration.
		Select the CDS account that represents your shareholdings.
		• Indicate your votes for the resolutions that are tabled for voting.
		 Confirm and submit your votes.
(f)	End of remote participation	• Upon the announcement by the Chairman on the closure of the 19 th AGM, the live streaming will end.

Note to users of the RPV facilities:

- 1. Should your application to join the 19th AGM be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.

- Shareholders can proceed to vote on the resolutions at any time from the commencement of the 19th AGM at 2.30 p.m. but before the end of the voting session which will be announced by the Chairman of the Meeting.
